City Manager's Report.

CITY MANAGER REPORT June 18, 2024

- 1. <u>Park Ten Road</u> The contract is for 309 Calendar Days with an end date of July 10th. All electrical wiring has been installed underground. Coast Electric poles will be removed once other contractors remove their equipment. The contractor is continuing with the sidewalk, irrigation, and lighting installation. Road work will start soon though weather may delay them.
- 2. <u>Beaux Vue 2</u> The contractor submitted the change order for this project. It will be on the next agenda. A notice to proceed date of July 8th has been set.
- 3. <u>Kaleki Way</u> The contract is for 120 days with an end date of August 6th. Contractor has started the work on Ieke and DH Drive North.
- 4. <u>Bayou Drive</u> –The project is for 90 days with an end date of August 4th. The road work is complete. The final details of the project are being addressed by the contractor. Striping, sod, hydroseed and guard rails need to be installed before the road is reopened.
- 5. <u>Noma Drive Phase 1b</u> The contractor has submitted all bonds and insurance. The notice to proceed date has been set for July 8th.
- 6. <u>Gex Drive Lighting</u> The engineer has reviewed submittals. The contractor is working on getting all the materials and completing a project schedule.
- 7. <u>Drainage Projects</u> All remaining ARPA funded projects are out for bid.
- 8. <u>Canal Dredging</u> The RESTORE council is amending the original contract to extend the end dates. We will have to wait until this is complete before an award letter is issued.
- 9. <u>Noma Drive Boardwalk</u> The grant agreement letter is on this agenda for approval as well as the work assignment for the engineer. Project timeline will be 3 months for design and 9 for completion.
- 10. <u>Montjoy Creek</u> The engineer will present an update to the project at the July 2nd meeting. The engineer has sent the requested information to USACE. The wetland delineation is the only item left from the RAI.
- 11. <u>Dog Park</u> The county plans to have the survey finished in advance of the BOS's July meeting wherein approval to submit the subdivision application to the City of Diamondhead will be obtained. The subdivision application and supporting documentation will then come to the City for the various approvals.
- 12. <u>Coon Branch</u> The engineer will present the initial design at the July 2nd council meeting for these four GOMESA projects.
- 13. <u>CRS</u> Beau and I met with Jennifer Rachal of Verisk for our kickoff meeting. We have scheduled the onsite visit for July 17th. Between now and then, Beau is collecting all documentation needed to provide to Verisk for our application.
- 14. <u>Indian Hill</u> The permit to develop Indian Hill (fill old pond and direct stormwater to another pond) will be issued this week. The address will be 5409 W Aloha Dr. There is no proposed building on the property yet. This permit is just for the civil/stormwater work.
- 15. <u>Prest Prop LLC</u> Property is being re-subdivided to sell off a portion to a developer to build an AutoZone store.

- 16. <u>Procedural Ordinance</u> We are finalizing the procedural ordinance with input provided by the council. I will send it to the council next week for review and place it on the next agenda for approval.
- 17. <u>Noma Drive Dredging</u> <u>No updated information this meeting</u>. The engineer expects to bid this summer. The project is to remove sediment in the Jourdan River to allow better boat access from the Noma Drive Boat Launch.
- 18. <u>Noma Drive Nature Trail</u> <u>No updated information this meeting</u>. The engineer has designed a route for this project and will present it at the July 2nd meeting. This will be the first phase of this project. The city will continue to seek grants for the additional phases.
- 19. <u>Detention Ponds</u> <u>No updated information this meeting</u>. Engineer has completed design on this project and will provide them to public works to complete the dredging.
- 20. <u>Kome Drive No updated information this meeting</u>. This will be to address driveway and landscape culverts on Kome Drive.
- 21. <u>Kalipekona Pond</u> -- No updated information this meeting. This project will dredge the south end of the pond to remove sediment.
- 22. <u>Pelican Cove Drainage Project</u> <u>No updated information this meeting</u>. Engineer has been provided with the work assignment and will begin the surveying on this project.

Email Request Received

- 1. <u>84126 Bayou Drive</u> Councilmember asked about two lots next to this address that were initially cleared by a contractor but have been left with a few trees and trash on the property. I have asked code enforcement to contact the current lot owner. The property owner has been contacted.
- 2. <u>8896 Kipapa Way</u> Councilmember asked for a compliance check at this address. I have forwarded this to code enforcement. <u>Code enforcement contact property owner</u>.
- 3. <u>Beaux Vue/Highpoint Ditch</u> Councilmember asked about the outfall ditch of Beaux Vue and Highpoint not draining. A work order was created to reshape the ditch. <u>Public Works is on another large job at this time</u>.
- 4. <u>568 Ahuli Place</u> Councilmember has reported that the ditch needs to be cleaned at and near this address. A work order has been created for public works. This will be addressed after the Ahuli Place project is completed.
- 5. <u>Diamondhead Drive East</u> Councilmember asked about tree limbs around the East Rec area of DH Drive East are hanging over the road and need to be trimmed. A work order has been created.
- 6. <u>City Hall Gazebo</u> Councilmember informed me the handicap rail on the gazebo is broken. A work order has been created. The Rail has been fixed.
- 7. <u>Maui Place</u> Councilmember received an email about several issues in this area. I have contacted animal control to address issues. Code enforcement will also be contacting residents regarding concerns in the area.
- 8. <u>79326 Diamondhead Drive East</u> Councilmember asked for public works to clean and reshape major drainage ditch next to this residence. A work order was created.
- 9. <u>63781 Diamondhead North</u> Councilmember emailed about there being glass on the street in front of resident's home. Glass was cleaned up.

- 10. <u>Kaleki Way Project</u> Councilmember asked about the company hired to do the drainage is piecing together cement drainage pipes together with a cement collar, but it doesn't appear to have cement sealing the bottom of the concrete pipe. This would cause water leakage. Lastly, the pipe already contains a good amount of dirt, debris and water bottles due to the length of time taking to seal the pipes together. This is going to clog drainage and slow down water. The contractor does not put pipe together with cement sealant it is a tar substance called ram neck on arch pipe or a rubber gasket on round pipe.
- 11. <u>The Oaks</u> HOA asked about removing "popcorn" trees from the area. A work order has been created for public works.
