CITY MANAGER REPORT

August 06, 2024

- 1. <u>MDOT Projects</u> –The closed off ramp is expected to be completed by the end of this month. The MDOT district engineer is asking the contractor to repair the Exit 20 off ramp as soon as possible due to its condition. School bus traffic is trying to split the Diamondhead routes to accommodate the ramp closure. They will continue to monitor the traffic and make changes as needed.
- 2. <u>Procedural Ordinance</u> The changes to the ordinance is as follows
 - a. Gender neutrality. Him/Her was inserted were needed.
 - b. Sec. 1-18. Decorum Generally
 - ...however, public comments may be made as set forth herein
- 3. Boy Scout Request The Boy Scouts have requested the following
 - a. Council Chambers for PAC meetings once a month (200+ attendees). The meeting will be 1-2 hours. Snacks and drinks will be served.
 - b. Activity Center once a week for den meetings (10-20+ attendees).
 - c. Use of facility to hold a Blue & Gold Banquet once a year. (Scouts and parents, dinner, and program).
 - d. Use of facility to hold the Pine Wood Derby once a year. (48-foot, 6 lane-track will be installed)
 - e. Use of facility to hold the annual Awards Presentation.

The current rental agreement would have to be amended to allow the reoccurring use, allow use of council chambers, and waive the rental fee.

- 4. <u>Park Ten Road</u> –The contract is for 403 Calendar Days with a current end date of October 12th. The contractor is working forward from the DWSD building towards Park Ten Lanes. The contractor is working around the utility pole that is in the work path. The sidewalks and lighting are being installed on the Leisure Time extension roadway.
- 5. <u>Beaux Vue 2</u> The notice to proceed was issued on July 8th. The contract is for 60 Calendar Days with a current end date of September 5th. The contractor has indicated that materials are three to four weeks out.
- 6. <u>Kaleki Way</u> Two change orders are on tonight's agenda. Change Order #02 is to adjust the contract total to account for the installed quantity differences. Change order #03 is to add additional piping and concrete structures in the resident's back yard and between two lots. This change order also adds an additional 35 days to the contract. If approved, the new substantial completion date will be September 10th. The contractor has sodded most of the disturbed areas and will hydroseed the remaining areas.
- 7. <u>Traffic Study</u> Two work assignments are on the agenda for traffic studies. The Highpoint signage review is at the request of the Highpoint HOA. Due to the increased traffic in the area, they would like additional signage. The second work assignment is a revised traffic study to review the need for an additional stop sign at Diamondhead Drive East and Golf Club Drive.
- 8. Noma Drive Phase 1b – The notice to proceed was issued on July 8th. The contract is for 180 Calendar Days with a current end date of January 7th. The contractor has installed the cofferdam and started removing the existing boat ramp.
- 9. Gex Drive Lighting This project has been completed and all punch list items have been resolved.

- 10. <u>Drainage Projects</u> The contracts for the ARPA project have been signed. The engineer will arrange pre-construction meetings with the contractors in the coming weeks.
- 11. <u>Canal Dredging</u> Contacted MDEQ regarding the grant agreement. Once received, it will be placed on the agenda for approval. The construction schedule is set to start in March/April of 2025.
- 12. <u>Noma Drive Boardwalk</u> We had our first monthly check in meeting in July. The permitting phase is progressing with all applications submitted. The engineer is working on the final design of the project.
- 13. <u>Coon Branch</u> Met with Harrison County engineer last month to discuss the stormwater. Chiniche Engineering is working on several options for design including the creation of detention ponds.
- 14. <u>CRS</u> We have submitted all CRS documentation required for FEMA to process and approve our application by August 17th. This would make the city active in the program by April 2025. The city should enter the program as a Class 8 or 9. After one year in the program, the city can submit for Class 7.
- 15. Noma Drive Dredging The engineer expects to advertise this project in September.
- 16. <u>Dog Park</u> The county approved the survey at their meeting yesterday and will submit it to the city for approval at the August 20th meeting.
- 17. <u>Montjoy Creek</u> No updated information this meeting. The engineer is waiting for the final permits to allow the project to go out for bid.
- 18. <u>Detention Ponds</u> No updated information this meeting. Engineer has completed design on this project and will provide them to public works to complete the dredging.
- 19. <u>Kome Drive</u> No updated information this meeting. This will be to address driveway and landscape culverts on Kome Drive.
- 20. <u>Kalipekona Pond</u> -- No updated information this meeting. This project will dredge the south end of the pond to remove sediment.
- 21. <u>Pelican Cove Drainage Project</u> No updated information this meeting. Engineer has been provided with the work assignment and will begin the surveying on this project.
- **22.** <u>Noma Drive Nature Trail</u> No updated information this meeting. The engineer presented the project to the council tonight.

Email Request Received

- 1. <u>Maui Place</u> Councilmember received an email about several issues in this area. I have contacted animal control to address issues. Code enforcement will also be contacting residents regarding concerns in the area.
- 2. <u>79326 Diamondhead Drive East</u> Councilmember asked for public works to clean and reshape major drainage ditch next to this residence. A work order was created. <u>Public works has spoken with the property owner and will address all issues.</u>
- 3. <u>7854 Maui Place</u> Councilmember contacted me about a sink hole forming and the ditch needing to be cleaned out to allow proper waterflow. A work order has been issued.
- 4. <u>85542 DH Drive West</u> Councilmember asked for a compliance review on this address. Code enforcement has already contacted the property owner. If they do not comply, a citation will be issued.

- 5. <u>7949 Hilo Way</u> Councilmember asked about erosion around culvert. A work order was created. Public works placed rip rap around the culverts to prevent further erosion.
- 6. <u>7816 Koko Ct</u> Councilmember asked about this address and the ditch erosion in the area. Public Works has been to the site. The city engineer will review the area to determine course of action.
- 7. <u>Alawai and DH Drive East</u> Councilmember asked that the shrubs in the median be trimmed to provide better line of site. <u>Public works has trimmed the shrubs</u>.
- 8. <u>7446 Turnberry Drive</u> Councilmember asked to put rip rap to stabilize ditch bank and prevent the erosion. A work order has been issued.
