City Manager's Report.

Jason Chiniche provided updates regarding the Devil's Elbow Restoration and East Aloha Widening Projects.

- 1. <u>Special Election</u> A special election will be held on March 3 to fill the vacancy for the council member from Ward 4. If you have any questions about this election or you are considering running for office, please contact Mrs. Jeannie Klein, our city clerk.
- 2. <u>Street Paving Project</u> Street paving project is moving along nicely. This is a 90-day project to pave 7.5 miles of roads in the city. Please remember to drive safely when workers are in your area. On the agenda tonight, I am requesting authorization to advertise to bid a second round of street paving on 3.5 miles of roads. We budgeted \$1.4 million, and our first round is costing about \$900K. So, we have funding in the planned budget to pave more streets. We are focused on the street in the worst condition in the city.
- 3. <u>TransUnion Agreement</u> I am asking council for authorization to approve a subscription with TransUnion for \$50 a month. This is being done in effort to gather certain information required by the State Department of Revenue for use in the new debt collection setoff program.
- 4. <u>Real Estate Purchase</u> I am asking for authorization to execute a contract to purchase real property for use as a right of way to extend Leisure Time Lane. This contract sets the purchase price at \$9,961, which is the higher of two appraisals for fair market value. We have already executed another contract for a different parcel, which the city is purchasing tomorrow. The docket of claims on the agenda tonight include the \$1,000 earnest money for the new parcel as well as the purchase price and closing cost for the Haas property the city is buying tomorrow.
- 5. <u>STEAM Program for Adults and Kids</u> The city of Diamondhead is partnering with Infinity Science Center to create a STEAM program for adults and kids in Diamondhead. We have planned events for March, April and May. This will include a monthly adult lecture series as well as a kids STEM program. We have already received 6 corporate sponsors to fund this program.
- 6. Recycling Dumpster We have now had the recycling dumpster for 2 weeks. We knew it would fill up quickly once it was delivered, and it did. We pulled it in less than a week. Now we pulled a second time in less than a week again. We are planning for 2 pulls a week to avoid having any trash put on the sides when it is full. We are receiving complaints from residents, especially one that lives across Diamondhead Drive North, about this location. They do not like looking at it, and she feels like it may smell during the summer. Unfortunately, the city does not own lots of real estate, and we are limited to a location. Previously the city put this dumpster behind city hall, but this was used as an illegal dumping site since it was out of sight. I am told that there was trash everywhere. So, we are trying to put it near the police station to help avoid illegal dumping. We are still trying to work out the appropriate pull dates with Waste Management based on our usage. I have also requested signs to help educate residents about what is actually recyclable goods and what is not. This location is not ideal, but if we want recycling in Diamondhead, this is our only option at this point. Waste Management has ordered 2 more dumpsters, so that when they pull a full dumpster, they will immediately drop an empty dumpster. But at present time, they do not have a spare, so our dumpster is actually removed to be dumped. I would also like to encourage residents to not drop recycling in the parking lot if the dumpster is not there. This constitutes littering. Please help us keep our city clean.
