Dear Mr. McCraw:

Please find attached for your review and approval Work Assignment No. 3B for the City of Diamondhead Beaux Vue Ph.2 Drainage Improvements. The proposed adjustment of fees of an additional \$5,435.00 is needed for additional construction administration services. The additional construction administration fee is needed for the re-design of the drainage improvements.

In May 2022 the City directed DE to design 30" RCAP storm drain line, as presented to the City Council, to provide capacity for a 100-year storm event. The replacement of the storm drain was not part of our original scope and no additional design fee was granted, except for additional topographical survey. This project was bid and awarded to Fair Tide Marine. After the preconstruction conference, held on February 21, 2024, there was blowback from the residents regarding the removal of crepe myrtles and an oak tree within the drainage easement. The City requested the DE explore alternatives to reroute the 30" RCAP to avoid the trees within the existing drainage easement. All alternatives that were explored still impacted the root zone of the of the oak tree, which would have resulted in the removal of the tree. The City later directed DE to eliminate the 30" RCAP storm drain and connect the new drainage ditch to the existing 24" HDPE storm drain line for the subdivision that was designed for a 25-year storm event.

The breakdown of the hours required for the redesign of the drainage improvements is as follows:

Senior Professional Engineer 34.5 hrs @ \$145/hr = \$5,075.00

4.0 hrs @ \$ 90/hr = \$ 360.00 Total = \$5,435.00

WHEREAS, the parties hereto do further contract and agree to add the following items of work to the above Agreement under the additional terms and conditions as are hereinafter stated:

## Scope of Work for the City of Diamondhead Beaux Vue Ph.2 Drainage Improvements

- Design (Hourly Not to Exceed) Includes field verification of the proposed drainage work, develop drainage alternatives and recommendations, design of drainage improvements, preparation of plans, specifications and a construction cost estimate, and review meeting(s) with the City.
- Topographical Survey (Lump Sum) Includes preparing of a topographic survey of the project area with elevations, cross-sections, existing structures, and pertinent drainage data. Topographical survey to be done by subconsultant Cassady Acadia Land Surveyors, LLC.
- 3. <u>Bidding</u> (Hourly Not to Exceed) –Includes responding to questions, holding a pre-bid meeting, preparing and issuing addendums, review and evaluation of bids received and making recommendation for award.
- Construction Administration (Hourly Not to Exceed) Includes holding a pre-construction meeting, attending regularly scheduled progress meetings, review and approval of submittals, review and approval of Contractor's pay estimates and substantial completion inspection.
- Resident Inspection (Hourly Not to Exceed) Includes the daily inspection of Contractor's work, preparation of daily inspection reports, and attending regularly scheduled progress meetings.

**NOW THEREFORE,** an adjustment of fees of an additional \$5,435.00 for additional Construction Administration, which has been mutually agreed upon by all parties for professional services

## WORK ASSIGNMENT TERM

No new Work Assignments shall be executed after October 28, 2025.

This WORK ASSIGNMENT shall be effective upon the latest date of execution. However, the Engineer may not begin work prior to receiving a Notice to Proceed.
