8. Adopt **Ordinance 2021-06**; An Ordinance of the Dillingham City Council Adopting the Budget and Appropriating Funds for the FY2022 City of Dillingham Budget

Ordinance 2021-06(A) incorporates the additional items noted in the City Manager memo. This budget is bare bones with no contingency built in. The State budget and ARPA funds are being monitored. Costs of materials, and insurance continue to rise. An asset list and replacement schedule is being developed. A formula will be coming to council for policy adoption. A dashboard for cash flow is being created to track cash flow trends.
