APPROVAL OF MINUTES

1. May 17, 2021, Finance & Budget Committee Meeting Minutes

- 2. May 31, 2021 Financial Report

NEW BUSINESS

- 3. ARPA
 - The State Legislature is scheduled to take this up in August. The City has passed a
 resolution to accept the funds. Expenditures that are approved loss of revenue, water /
 sewer projects, and direct COVID expenses.
- 4. State of Alaska Budget
 - The Legislature is scheduled for a special session. Up for discussion budget; permanent fund dividend amount, school bond, reverse sweep on CVR.
- 5. School Bond Payment

- May be discussed at special session in August.
- 6. Equipment Replacement Strategy
 - Asset list is being compiled. Policy decisions will need to be determined on how long equipment is viable.
 - Consider contacting the Tribal Council to partner with the City, contribute funding on water / sewer projects and equipment.
- 7. Ekuk COVID Funds
 - Ekuk Tribal Council wants to contribute \$50,000 towards enforcement. Need a proposal from the City. Manpower, and anticipated changes to COVID regulations mid-July are a concern.
- 8. Capital Projects Update
 - Aeration project will be going out for bid.
 - Lake Road Fire Hall nearing completion.
 - Landfill fire building replacement flooring can be used, looking into if steel girds can be used as well. Replacement vehicle is currently unavailable.
