- 9 new LED street lights were proposed in the project. The city would be billed for the electricity.
- Suggested use of city land would be for staging of equipment and stockpile of usable material for future use.
- Anticipated amount of fill; Phase I 7,000 yards; Phase II 13,000 yards, suitable for use at the landfill.

 - Need to establish talking points and determine the best timeframe for the trip.
- 10. Comprehensive Plan Study
 - The current plan is 13 years old, making it out of date. Some projects have been finished or changed, and the plan no longer reflects the complete focus of the city.
 - Requested estimate cost for an update to the comprehensive plan.
 - Noted the City has a BBEDC grant for grant writing assistance through Agnew Beck.

- Stated a need to look for and identify lands suitable for subdividing, to reconvey, have on the tax roll, and address the housing crisis.
