New Business

A. Introduction and Review of Hearing Procedures

- The Chair reviewed applicable **Board of Equalization procedural guidelines** from the BOE Handbook, including:
 - Section IV.A.10(a)
 - Sections IV.B.1 and IV.B.2
 - Section V
- The Board confirmed that the purpose of the hearing was **solely to determine whether the appellant was unable to comply with the 30-day appeal filing requirement**, not to hear the merits of the appeal itself.
- Sample motion language and guidance on late-file appeals were reviewed.

B. Consideration of Request to Late-File an Appeal

Hearing:

- Determination of whether **Travis Handy** was unable to comply with the 30-day appeal window.

Motion:

- Moved by **Steve Carriere** to **reject the late-file appeal**
- Seconded by **Jean Barrett**

Discussion Highlights:

- Board members discussed the taxpayer's responsibility to maintain current contact information with the City.
- It was noted that property tax notices were mailed to the address on file and that failure to receive notice was not attributable to City error.

- One member expressed support for allowing the appeal based on personal circumstances; others emphasized statutory responsibility and precedent.
