1. Fee Schedule

Discussion:

2. Procurement – Advertising Requirements

Discussion:

- Current code requires advertisement only in the local newspaper.
- Proposed to expand procurement advertising to include:
 - Posting on City website.
 - Posting on City's Facebook page.
 - Newspaper publication retained but not sole method.
 - Purpose: Increase transparency, reach more residents, and reduce reliance on limited newspaper circulation.

Motion:

- Recommend amending procurement code to allow official posting on City website, Facebook, and newspaper as acceptable methods of public notice.
- Motion passed unanimously.
