### I. CALL TO ORDER AND ROLL CALL

  The Iowa County Historical Society issued a thank you letter to the City for their annual contribution of \$5,000.

7. Discussion and possible action to approve a funding request from the "Love Dodgeville" Planning Committee

Barry Hottman was present to request funds for the "Love Dodgeville" activities planned in May. The organization performs a number of good deeds around the City including cleaning up trails, beautifying the welcome signs, providing May baskets to care facilities among others. The group is hoping to raise \$2,000+ for this year's activities. ARPA funds need to be designated and it's possible the City may designate some funds for 2024 as well.

Motion made by Meuer, Seconded by Reynolds-Lair to transfer \$2,000 of ARPA funds to the Love Dodgeville account. Roll call vote. Motion carried 8-0. Voting Yea: Reynolds-Lair, Sersch, DeVoss, Weber, Meuer, Johnson, Johnson-Solberg, Tremelling

8. Discussion and possible action to approve a road use agreement with American Transmission Company LLC (ATC) as related the Cardinal-Hickory Creek project.

PW Director Lee presented a road use agreement with ATC for use of City roads during the implementation of the Cardinal-Hickory Creek project. A map of proposed roads is attached to the agreement. The City doesn't really have an option, because ATC can use the roads regardless of this agreement. The agreement allows for a one-time payment of \$5,000 and an additional \$500 per load over 80K lbs. A rating baseline has been established and the City will be compensated additionally for any damage after the transmission line is complete.
