## **RESOLUTION NO. 24-1581**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF DOUGLAS, COCHISE COUNTY, ARIZONA, AUTHORIZING THE ENTRY INTO AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF DOUGLAS AND THE DOUGLAS UNIFIED SCHOOL DISTRICT NO. 27 FOR PURPOSES OF **PROVIDING DOUGLAS** POLICE **DEPARTMENT** TO FILL TWO SCHOOL SAFETY PERSONNEL **OFFICER** POSITIONS WITHIN THE DISTRICT IN THE CITY OF DOUGLAS.

WHEREAS, the City of Douglas, by way of the Douglas Police Department, seeks to enter into an Intergovernmental Agreement with the Douglas Unified School District No. 27, to provide for the terms and responsibilities with respect to the School Safety Officer (SSO) Program; and

WHEREAS, the SSO program will consist of two, full-time Douglas Police Department (DPD) personnel, who are Peace Officers for the State of Arizona who meet all requirements as set forth by DPD rules and regulations, with DPD assigning one such officer to the Ray Borane Middle School and the Paul Huber Middle School: and

WHEREAS, based on well-established regulations, the city and the district may contract for services and enter into agreements with one another for joint or cooperative action, pursuant to A.R.S. §11-952 and the district is further authorized to enter this IGA pursuant to A.R.S. §15-342.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Douglas, Arizona, as follows:

- **Section 1.** The terms and conditions of the Intergovernmental Agreement to be entered into by the parties is attached in Exhibit "A" and incorporated herein by reference as though fully set forth herein verbatim and are found to be in the best interest of the City of Douglas.
- 16 **Section 2.** The Intergovernmental Agreement for the SSO Program is hereby authorized and approved.
- 17 Section 3. The City Manager and the City Clerk are hereby authorized to execute and deliver the Intergovernmental Agreement and any related documents necessary to consummate the transaction contemplated by the agreement for and on behalf of the City of Douglas.
- Section 4. The officers of the City Council and the City of Douglas are hereby authorized and directed to fulfill all obligations under the terms of the Intergovernmental Agreement. 20
