- 4. DISCUSSION/DECISION on APPROVALS.
- A. **RESOLUTION NO. 25-1672,** a Resolution of the Mayor and Council of the City of Douglas, Cochise County, Arizona, **ADOPTING** the **BUDGET** for **FISCAL YEAR 2025-2026.**

Mr. Martinez explained that Arizona law requires a public hearing before finalizing municipal budgets, which was held today at 5:15 p.m. The final budget cannot exceed the tentatively adopted budget from June 11, 2025. On June 30, 2025, the state provided updated revenue projections, resulting in an \$8,145 reduction for the city. This minor change was adjusted in the general government contingency line, and no other changes were made to the June 11 budget.

Motion by Council Member R. Acosta, second by Council Member Shelton to approve Resolution No. 25-1672.

Council Member R. Acosta expressed appreciation to the city manager, staff, and departments for their hard work on the budget, acknowledging that the effort began in early January.

Mayor Grijalva thanked staff for providing funding options, responding to community needs, and making the council look good through their work.
