1 A RESOLUTION OF THE MAYOR AND COUNCIL OF **COCHISE** 2 THE CITY OF DOUGLAS, ARIZONA, AUTHORIZING THE EXECUTION OF A SERVICE AGREEMENT RENEWAL BETWEEN THE 3 OF DOUGLAS AND THE SOUTHEASTERN ARIZONA GOVERNMENTS ORGANIZATION (SEAGO) 4 IN THE AMOUNT OF \$20,000 TO BE USED IN THE TRANSIT PROGRAM TO MAINTAIN SERVICES FOR 5 ELDERLY AND DISABLED INDIVIDUALS IN THE CITY OF DOUGLAS AND SURROUNDING COMMUNITY. 6 WHEREAS, the Southeastern Arizona Governments Organization (SEAGO) and the City of Douglas seek to renew their service agreement to maintain transportation services for elderly and disabled members of our 7 community under the City of Douglas managed transit program; and 8 WHEREAS, the Service Agreement will augment the services provided through the ADOT Section 5311 Rural Public Transportation Grant Program, by providing matching funds in the amount of approximately 9 \$20,000; and 10 WHEREAS, related documentation providing the terms and conditions of said agreement entered into by the parties is attached in Exhibit "A", and incorporated herein by reference; and 11 WHEREAS, the best interest of the City of Douglas and the transit program will be served by entering into 12 this agreement providing needed transportation to elderly and disabled individuals in our community. 13 NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of Douglas, Arizona, as follows: 14 Section 1 The terms of said agreement with the Southeastern Arizona Governments Organization (SEAGO) are 15 in the best interest of the City of Douglas. 16 Section 2. The City Manager and the City Clerk are hereby authorized to execute and deliver the renewal of agreement in the amount of \$20,000 with the Southeastern Arizona Governments Organization (SEAGO) and any related documents necessary to consummate the transaction contemplated by the renewal of agreement 17 for and on behalf of the City of Douglas. 18 Section 3.
