WASHINGTON AVENUE AND E. HIGHWAY 80 (APN 41010008) located in DOUGLAS, ARIZONA, from SINGLE-FAMILY RESIDENTIAL 32,000 (SFR32) to GENERAL COMMERCIAL (GC) and AMENDING the OFFICIAL ZONING DISTRICTS MAP, established by Ordinance 691 and AMENDED by Ordinance 858 and Ordinance 22-1145; establishing severability of components of Ordinance; and establishing an effective date thereof.

EXECUTIVE SUMMARY:

The Planning and Zoning Commission met on May 17, 2022, and recommended to the City Council to approve the proposed rezoning of the one (1) parcel (numbered as Cochise County parcel number 41010008) situated within the Southeast ¼ of the Northeast ¼ Section 6, Township 24 South, Range 28 East at the northwest corner of the intersection of N. Washington Avenue and E. Highway 80.

BACKGROUND:

Amending the Zoning Districts Map from Single-Family Residential 32 (SFR32) to General Commercial (GC) for one (1) parcel situated within the Southeast ¼ of the Northeast ¼ Section 6, Township 24 South, Range 28 East at the northwest corner of the intersection of N. Washington Avenue and E. Highway 80, totaling approximately 3.72 acres is consistent with General Plan policies.

DISCUSSION & RECOMMENDATION:

The proposed Zoning Districts Map amendment is consistent with General Plan goals, objectives and policies. Staff recommends approval of Ordinance 22-1150.
