**RESOLUTION NO. 23-1552** 1 A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF DOUGLAS, COCHISE COUNTY, ARIZONA, AUTHORIZING THE 2 EXECUTION OF AN EXTENSION TO THE BUILDING LEASE AGREEMENT BETWEEN THE CITY OF DOUGLAS AND THE 3 ARIZONA BOARD OF REGENTS, TO CONTINUE TO PROVIDE SPACE FOR THE DOUGLAS ANIMAL SHELTER AT 2017 ROGERS 4 AVENUE, IN THE CITY OF DOUGLAS, ARIZONA. 5 WHEREAS, Article I, Section 3. (A) of the City Charter empowers the City to lease real property for any City purpose and to sell or otherwise dispose of real property in the manner, for such consideration and upon such conditions as may be determined by the City Council; and 6 WHEREAS, the City of Douglas and the Arizona Board of Regents, a body corporate, seek to enter into an Extension 7 to the Building Lease Agreement, extending the term of the lease entered into August of 2015, in order to continue to provide space for the Douglas Animal Shelter at 2017 Rogers Ave., in the City of Douglas; and 8 WHEREAS, the Extension to the Building Lease Agreement of this facility, providing the terms and conditions of 9 said lease extension, is attached as Exhibit "A" and incorporated herein by reference; and 10 WHEREAS, the Mayor and Council find that it is in the best interest of the City to continue to lease the noted premises pursuant to the terms and conditions in the attached proposed Amendment to Building Lease Agreement. 11 NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Douglas, Arizona, as follows: 12 Section 1. The Extension to the Building Lease Agreement, with the Arizona Board of Regents, a body corporate, 13 as it relates to the subject facility at 2017 Rogers Ave., in the City of Douglas is hereby approved and the execution of same is authorized. 14 Section 2. The City Manager and the City Clerk are hereby authorized to execute and deliver the Extension to the 15 Building Lease Agreement, attached hereto as Exhibit "A", and any related documents necessary to effectuate the lease extension contemplated by the extension, for and on behalf of the City of Douglas. 16 Section 3.
