3. **ZCA-2023-01 Administrative Codes Text Amendment.** Updating, revising, and amending code text in several articles of the Zoning Code (Section 2.32.030, Articles 1, 2, 3, 4, Sections 5.513, 5.514, and Articles 10, 11, 12, 13, 14 of Title 17 and Chapter 15.08 of DMC) to correct omissions and errors in numeration, spelling, and recognize practical organizational changes and authorities, improve definitions of minor decisions and increase flexibility for and clarity of processes for administrative approvals.

4. **ZCA-2023-03 Innovative Community Overlay Zoning Districts Code (IC-R, IC-C, IC-MU) Text Amendment.** Creation of a new series of overlay districts proposed as DMC§17.05.516 that may be designated by zoning district map amendments.
