AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF DOUGLAS, COCHISE COUNTY, ARIZONA, AUTHORIZING THE SALE OF FIVE VACANT PARCELS OF LAND LOCATED ON BLOCK 2 OF RANCHO LA PERILLA ESTATES, WITH ASSESSOR'S PARCEL NUMBERS 410-08-13505, 410-08-15204, 410-08-15101, 410-08-07803, AND 410-08-14504 TO SATOW LLC, PURSUANT TO TERMS ENTERED INTO BY THE PARTIES; ESTABLISHING SEVERABILITY OF COMPONENTS OF ORDINANCE; AND ESTABLISHING AN EFFECTIVE DATE THEREOF.

WHEREAS, Article I, Section 3 (A) of the City Charter empowers the city to acquire real property for any City purpose and to sell or otherwise dispose of real property in the manner, for such consideration and upon such conditions as may be determined by the City Council;

WHEREAS, Article VII, Section 5 (12) of the City Charter provides that the acquisition, sale, lease or exchange of real property shall be by ordinance;

WHEREAS, the Mayor and Council find that it is in the best interest of the City of Douglas to sell five (5) vacant parcels of land located on Rancho La Perilla Block 2, with Assessor's Parcel Numbers 410-08-13505, 410-08-15204, 410-08-15101, 410-08-07803, and 410-08-14504 in Douglas, Cochise County Arizona to SATOW LLC, an Arizona Limited Liability Corporation, for a total purchase price of \$25,000.00 per the terms of the Purchase and Sale Agreement, which is attached and incorporated herein by reference; and

WHEREAS, the Mayor and Council find that the sale of vacant real property is in the best interest of the city pursuant to the terms and conditions of the terms described in the Purchase and Sale Agreement as entered into by the parties.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Douglas, Arizona, as follows:

Section 1. The city is authorized to sell to SATOW LLC for a total purchase price of \$25,000.00, plus any related costs associated with closing, pursuant to the terms of the Purchase and Sale Agreement, the real property described below:

Legal Descriptions: RANCHO PERILLA ESTATES BLK 2 LOT 59; RANCHO PERILLA ESTATES BLK 2 LOT 76; RANCHO PERILLA ESTATES BLK 2 LOT 75; RANCHO PERILLA ESTATES BLK 2 LOT 69 identified as Assessor's Parcel Numbers 410-08-13505, 410-08-15204, 410-08-15101, 410-08-07803, and 410-08-14504 in Douglas, Cochise County, Arizona,

Section 2. Approving the terms of the Purchase and Sale Agreement, attached hereto and incorporated herein by reference.

Section 3. The City Manager and the City Clerk are authorized and directed to sign and execute all documents necessary to consummate the sale of the subject property.

1	Section 4. This ordinance shall be effective thirty (30) days after final approval and adoption by the Mayor and Council.
2	Section 5. Severability. If any chapter, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance
