10	 Improve access to capital for economic development and entrepreneurship; and Sustain the delivery of the SGR Core Curriculum for continued community benefit; and 	
11	WHEREAS , the City of Douglas agrees to designate or hire a Community Coordinator (CC) who will serve as the main liaison between the city and RCAC for the duration of the three-year RCDI grant partnership; and	
12 13	WHEREAS , the City of Douglas will receive \$45,000 over a three-year period from RCAC to support the activities of the designated Community Coordinator.	
14	NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Douglas, Arizona, as follows:	
15	 The City of Douglas accepts the grant agreement with RCAC as a subgrantee of the USDA RCDI grant The city agrees to designate or hire a Community Coordinator to serve as the primary point of contact and to implement the scope of work outlined in the RCDI partnership. The City Manager and the City Clerk are hereby authorized to execute the grant agreement and any related documents necessary to implement this partnership. The city shall comply with all applicable terms, conditions, and reporting requirements set forth by RCAC and USDA for the duration of the grant period.
