A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF DOUGLAS, COCHISE COUNTY, ARIZONA, RATIFYING THE EXECUTION OF A SERVICE AGREEMENT RENEWAL FOR SFY25 BETWEEN THE CITY OF DOUGLAS AND THE SOUTHEASTERN ARIZONA GOVERNMENTS ORGANIZATION (SEAGO) IN THE AMOUNT OF \$20,000 AND A SUBAWARD AMENDMENT IN THE AMOUNT OF \$10,000 TO BE USED IN THE TRANSIT PROGRAM TO MAINTAIN SERVICES FOR THE ELDERLY AND DISABLED INDIVIDUALS IN THE CITY OF DOUGLAS AND SURROUNDING COMMUNITY.

**WHEREAS**, the Southeastern Arizona Governments Organization (SEAGO) and the City of Douglas seek to renew their service agreement to maintain transportation services for elderly and disabled members of our community under the City of Douglas managed transit program ("Service Agreement"); and

**WHEREAS**, the Service Agreement with SEAGO will augment the services provided through the ADOT Section 5311 Rural Public Transportation Grant Program, by providing matching funds in the amount of approximately \$20,000 and a Subaward Amendment to redistribute available funds in the amount of \$10,000, for a total grant of \$30,000; and

11 **WHEREAS**, to ensure continuation of services, the City Manager and the City Clerk executed the Service Agreement with SEAGO, which is attached and incorporated herein by reference; and

WHEREAS, the best interests of the City of Douglas and the transit program will be served by entering into this agreement providing needed transportation to elderly and disabled individuals in our community.

**NOW, THEREFORE BE IT RESOLVED**, by the Mayor and Council of the City of Douglas, Arizona, as follows:

**Section 1**. The terms of said Agreement with the Southeastern Arizona Governments Organization (SEAGO) are in the best interest of the City of Douglas.

Section 2. The Services Agreement with SEAGO, previously executed by the City Manager and the City Clerk and attached hereto and incorporated herein by reference, is ratified. Further, the City Manager and the City Clerk are hereby authorized to execute and deliver the subaward amendment in the amount of \$10,000 with the Southeastern Arizona Governments Organization (SEAGO) and any related documents necessary to consummate the transaction contemplated by the renewal and subaward agreements for and on behalf of the City of Douglas.

20 **Section 3.** The officers of the City Council and the City of Douglas are hereby authorized and directed to fulfill all obligations under the terms of the Agreements.
