EXECUTIVE SUMMARY:

The Planning and Zoning Commission met on March 27, 2025, and recommended approval to the City Council for the proposed rezoning of one (1) parcel number 41024006 located at GERONIMO TRAIL EST LOTS 30 THRU 32 INC.

BACKGROUND:

Amending the Zoning Districts Map Amendment from Single Family 12,000 (SFR12) to Multi-Family Residential (MFR) for a parcel of land situated within the GERONIMO TRAIL EST LOTS 30 THRU 32 INC, Assessor Parcel Number 41024006; totaling approximately 1.44 acres is consistent with General Plan policies particularly those focused on land use.

DISCUSSION:

The proposed amendment to the Zoning Districts Map aligns with and advances the goals, objectives, and policies outlined in the General Plan to increase residential land development and usage. Rezoning reflects the evolving development patterns in the area and aims to accommodate compatible housing uses in the vicinity. Specifically, the proposed zoning change for APN 41024006, from Single Family 12,000 (SFR12) to Multi-Family Residential (MFR), is a strategic decision that supports the City of Douglas's General Plan and development objectives. This change will enable the applicant to develop homes with the standards of Multifamily Residential.

Staff recommend approval, as it is a sound recommendation in accordance with guidance from the General Plan.
