13	<b>WHEREAS,</b> the GSA requests that the city grant a Non-Exclusive Easement for construction access to the new commercial port of entry construction site as more specifically identified in Exhibit "A" attached.
14 15	<b>NOW, THEREFORE, BE IT RESOLVED,</b> by the Mayor and Council of the City of Douglas, Arizona, as follows:
16 17	<b>Section 1.</b> Approve and hereby grant the Non-Exclusive Easement, a copy of which is attached as Exhibit "A" and incorporated herein by reference, is in the best interest of the City of Douglas.
18	<b>Section 2.</b> The City Manager and the City Clerk are hereby authorized to execute and deliver the Non-Exclusive Easement and any related documents necessary to consummate the transaction contemplated by this Non-Exclusive Easement for and on behalf of the City of Douglas.
20	<b>Section 3.</b> The officers of the City Council and the City of Douglas are hereby authorized and directed to fulfill all obligations under the terms of the Non-Exclusive Easement.
