## FIRM QUALIFICATIONS

Ramírez Advisors Inter-National, LLC (RAI-N) proposes an approach that builds on its extensive experience supporting economic development initiatives in Douglas and across the Arizona-Sonora border region. The firm will work closely with City leadership to define priorities, align stakeholders, and implement strategies that advance the City's economic development goals—particularly those associated with the Douglas/Agua Prieta port of entry system.

### **Strategic Focus: Douglas Two-Port Solution**

RAI-N's primary focus will be to support the successful implementation of the Douglas Two-Port Solution, including completion of the Douglas West commercial port of entry and the modernization of the Raúl H. Castro port of entry. This work will include close coordination with U.S. and Mexican stakeholders to ensure that infrastructure investments, operational planning, and policy alignment support the efficient movement of goods and people.

This coordination will focus exclusively on issues related to the Douglas Two-Port Solution and associated infrastructure, logistics, and economic development initiatives as directed by the city.

### **Advocacy and Legislative Support**

RAI-N will assist the city in advancing initiatives before the Arizona State Legislature and in responding to requests for information from Arizona's Congressional delegation. The firm will also support meetings with Congressional offices within Arizona to advance awareness and support for the Two-Port Solution. RAI-N will coordinate efforts through the city to ensure we avoid duplication of efforts with the city's state and federal lobbying advisory firms.

## **Communications and Strategic Messaging**

RAI-N will provide strategic communications support to ensure consistent, accurate, and effective messaging related to Douglas' economic development priorities. This will include:

RAI-N will coordinate and support engagement with Mexican stakeholders at the local, state, and federal levels. This will include scheduling and facilitating in-person meetings and binational virtual meetings, as appropriate, as well as coordinating travel to Mexico for senior-level engagements when necessary.

The firm will also:

- Participate in Douglas Port of Entry Technical Team meetings
- Advocate for inclusion of the Two-Port Solution on agendas for key regional and binational meetings
- Provide a minimum of four (4) trips per year to Douglas to support city activities, initiatives, and stakeholder engagement, timing of these trips to be determined after discussion with the city leadership
- Perform additional activities, as appropriate, to advance the Douglas Two-Port Solution and related economic development projects
