

RESOLUTION NO. 26-1715

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE
CITY OF DOUGLAS, COCHISE COUNTY, ARIZONA,
ACCEPTING GRANT FUNDING FROM THE LEGACY
FOUNDATION OF SOUTHEAST ARIZONA FOR PROJECT
LIFELINE: ADVANCING CPR WITH INNOVATION, IN
THE AMOUNT OF \$50,000.**

WHEREAS, the City of Douglas Fire Department provides emergency medical services to residents of Douglas and surrounding rural areas and strives to improve cardiac arrest care and patient outcomes; and

WHEREAS, evidence-based, uninterrupted, high-quality chest compressions are essential to survival in cardiac arrest, and automated piston-style chest-compression devices can enhance CPR quality, responder safety during transport, and operational efficiency, particularly in limited-staffing conditions; and

WHEREAS, the Legacy Foundation of Southeast Arizona has awarded the City of Douglas a grant in the amount of \$50,000 to fund the purchase of two piston-style automated chest-compression devices for use in city ambulances; and

WHEREAS, the grant award does not require city matching funds, and acceptance of this funding will allow the Fire Department to procure and deploy these devices consistent with city policies; and

WHEREAS, acceptance of the grant and timely implementation of Project Lifeline: Advancing CPR with Innovation will strengthen the city's life-saving capabilities and benefit residents and patients served by Douglas Fire Department.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Douglas, Arizona, as follows:

Section 1. The City of Douglas hereby formally accepts the grant award from the Legacy Foundation of Southern Arizona in the amount of \$50,000 for Project Lifeline: Advancing CPR with Innovation.

Section 2. The City Manager and the City Clerk are authorized to execute all necessary documents, agreements, and reports required to accept and administer the grant.

Section 3. The city agrees to comply with all applicable federal, state, and local laws, regulations, and grant conditions.

Section 4. This resolution shall become effective immediately upon its adoption.

BE IT FURTHER RESOLVED, that the City of Douglas expresses its sincere gratitude to the Legacy Foundation of Southeastern Arizona for their support, which will significantly contribute to the development of the community.
