Ms. Andrade stated no public participation requests were submitted.

5. PRESENTATION/DISCUSSION on the PUBLIC HEARING:

A. The purpose of the PUBLIC HEARING is to allow public participation regarding an INCREASE to the WATER and SEWER rates.

Luis Pedroza provided background information regarding water and sewer rates increases and the following bullet points:

- Determination to Recommend Increases
- Study determined current rates are inadequate
- Rates not increased since 2012
- Douglas Rates lower than average county and state rates
- What are the needs for the increase
- · How much will it increase?
- Water \$4.02 at the end of year 5.
- Sewer \$5.42 at the end of year 5.
- Water bill example

Council Member Shelton inquired if the city had any generators available.

Mr. Pedroza responded that not currently.

Council Member Shelton inquired on the possibility of getting grants in order to get a new Well.



In response, Mr. Pedroza mentioned it was the first option to seek grants.

Further, Council Member Shelton inquired if the low-income individuals would qualify for assistance.

Mr. Pedroza stated that the city wanted to bring a separate item to look at alternatives to offer discount not only on water and sewer, but also a garbage discount. Additionally, Mr. Pedroza mentioned that there was an option also for reducing pickups for sanitation in exchange for a lower rate and that the city was exploring rates but only for low income individuals.

Moreover, Mr. Pedroza mentioned that staff would like to bring proposals associated with services.

Mayor Huish provided an opportunity for the public to comment.

- Mrs. Ida Pedrego of 1815 E. 5th Street of Douglas commented on the following:
 - Mayor and Council are not representing the constituents of Douglas.
 - The 431 cities in the state of Arizona, Douglas is near the top, it is the 14th highest in city sales tax.
 - There are 13 cities of 431 that pay more taxes that we do city taxes.
 - Awareness of upcoming expenses rather than presented gradually.
 - City council responsibility to look at things to prevent increases and to tax the community.

Mayor thanked Ms. Pedrego.

Mr. Pedroza added that the SCADA system was different than the AMI system mentioned by Mrs. Pedrego. Moreover, Mr. Pedroza stated the AMI system was the automated meters that provide readings constantly without having to manually read; and SCADA was a different software system.

Mayor Huish commented the city had a very successful light parade and wanted to recognized winners. Mayor Pro Tempore Morales provided certificates to winners.

Motion by Council Member Morales, **second** by Council Member Acosta to approve the consent agenda items as presented.

8. DISCUSSION/DECISION on APPROVALS.

A. **THIRD READING OF ORDINANCE NO. 21-1141,** an Ordinance of the Mayor and Council of the City of Douglas, Cochise County, Arizona, AMENDING TITLE 13 of the DOUGLAS MUNICIPAL CODE relating to PUBLIC WATER and SEWER services by amending Ordinances 755, 06-904, 09-973, 20-1117 pertaining to WATER and SEWER FEES and CHARGES for SERVICES under Chapter 13.08, establishing severability of components of ordinance; and establishing an effective date thereof.

Luis Pedroza stated the topics were covered during the public hearing prior to this regular meeting. However, Mr. Pedroza commented the city would keep the credit card transactions fee waiver.

Motion by Council Member Morales, **second** by Council Member Baldenegro to approve the third reading of Ordinance No. 21-1141.

Council Member Lindemann thanked Mr. Pedroza for the information presented reference exempting the credit card transaction fee as there was some savings. Moreover, Council Member Lindemann added that Mr. Pedroza mentioned on city services and that the city was doing its best to mitigate, and also supported some of the points addressed by Mrs. Pedrego.

Furthermore, Council Member Lindemann expressed that unfortunately the city needed to have the increase in water and sewer, and added he was part of the Finance Committee back in 2008 when fees needed to increased at the time and stated it was necessary as well.

Mayor Huish directed staff to look at potential savings and bring back to council during budget sessions and to see how would impact budget for the next fiscal year.

Council Member Grijalva thanked Mr. Pedroza for the work done and also mentioned his Ward was struggling with the increased as constituents had been very vocal about it. Furthermore, Council Member Grijalva added every time he would visit city hall, staff was looking into potential savings for constituents.

Council Member Shelton mentioned the need to help low income individuals with the fee increased situation.

Council Member Acosta referred to Mrs. Pedrego's different needs in the community which accumulated through the years and that all happened at once. Additionally, Council Member Acosta stated some of the needs could have been addressed sooner than later and working to prevent some of the deterioration not to have all compound at once.

Moreover, Council Member Acosta expressed she made the same point on different city facilities deterioration and staff needed to take care of issues as soon as they become aware and not let them linger until it becomes almost an emergency.

Lastly, Council Member Acosta mentioned there was still time to think about, and didn't understand the rush on the specific topic, however, understood some of the item needs, but the city could be more creative to get resources to fix.

B. **RESOLUTION NO. 21-1482**, a Resolution of the Mayor and Council of the City of Douglas, Cochise County, Arizona, AUTHORIZING the EXECUTION of a MEMORANDUM of UNDERSTANDING between the CITY of DOUGLAS and COCHISE COUNTY to COLLABORATE on possible grants and other funding sources for the DESIGN and CONSTRUCTION of WATER and SEWER SERVICES for the NEW COMMERCIAL PORT OF ENTRY.



Ana Urquijo provided background information and added that Cochise County and the city have worked on increasing partnerships and having the same goals towards the commercial port of entry by formalizing the efforts on initial phases already invested in and preliminary studies.

Moreover, Ms. Urquijo stated that the partnership would also be for continued funding and efforts in the same direction.

Motion by Council Member Lindemann, second by Council Member Shelton to approve Resolution No. 21-1482.

Council Member Lindemann expressed that everyone had been waiting for the new port of entry for an approximate time of thirty years and now was coming to fruition. Additionally, Council Member Lindemann was pleased with the opportunities that it would bring to the community.

Mayor Huish thanked Cochise County Administration, especially Ms. Ann English, Board of Supervisor's representative for this area and also recognized the great economic impact it would have not only in Douglas, but in the entire county. Additionally, Mayor Huish added that the city has the assistance of the Arizona Department of Transportation to get some of the projects done along with the county's expertise as far as acquiring right ways, therefore the city would work together with those entities.

Moreover, Mayor Huish commented the city would also seek other ways to be able to gain to leads on possible funding sources and staff was excited about it.

9. CITY MANAGER REPORTS.

Ms. Urquijo provided the following reports:

- The possibility of strengthening broadband and internet connectivity in the community which would come along with the water and wastewater infrastructure.
- Opportunity to partner in grant effort and support with Cox Communications which the application was submitted to the Arizona Rural Broadband for the City of Douglas community, and that the city submitted a support letter for such grant; and if approved it would be an approximate total of \$9M which would include fiber to home and fiber to business.
- Endowment Fund to allow community member to make tax free donations into a platform to have proactive benefits to the community as well.
- Recently process internal interviews for the Deputy City Manager position and have made Mr. Luis Pedroza
 the new Deputy City Manager, and would continue through council's appointment as city treasurer. Further,
 Ms. Urquijo mentioned council would be updated on continued restructuring.

10. INFORMATIONAL ITEMS AND REPORTS FROM COUNCIL AND FUTURE AGENDA ITEM REQUESTS.

Council Member Grijalva reminded everyone about commodity's day at the Douglas Area Food Bank which would be on the 20th and volunteers were needed, especially during the Holiday season. Further, Council Member Grijalva commended Chief Fullen for his appointment with Homeland Security Regional Advisory Council which might be beneficial to bring Federal monies to the community.

Lastly, Council Member Grijalva thanked Parks and Recreation Department for the Christmas Light Parade and Tree Lighting Ceremony in which received very positive comments and kids had fun as well.

Council Member Lindemann commended Chief Fullen, Jennifer Smith and Mr. Pedroza as he appreciates all.

Council Member Morales commented as the year comes to close wished everybody Happy Holiday Season and stated it had been a difficult year for everybody, and was thankful for the staff the city has as all do a tremendous job and was very proud they are part of the city. Moreover, congratulated Mr. Pedroza as Deputy City Manager.



Further, Council Member Morales was hopeful for 2022 to be a much better year and for COVID to go away.

Council Member Shelton echoed on Council Member Morales' comment and city staff was very professional, congratulated Chief Fullen as well and prayers to the community. Lastly, Council Member Shelton wished everybody Happy Holidays and briefly mentioned that the Christmas Light Parade was exceptional.

Mayor Huish added that it was very difficult for him to comment on but many of you have noticed his weight loss which has not been on purpose, he's dealing with health issues and it has been hard to get in to see doctors nowadays. Additionally, Mayor Huish stated he was able to schedule an appointment and has a plan to attack his illness, wanted to make the community aware, and expressed that everything was going to be well, since life was good and has a lot of faith and would get through.

Furthermore, Mayor Huish wished everybody a Merry Christmas which was an important part of the year in which we all needed to spend time and know what is important to all of us, and at the same time, to make resolutions to see what we can improve not only with our own lives, but with the community.

Lastly, Mayor Huish commented that sometimes everyone would disagree but would be supportive to each other and that we would always be a family.
