6	PROTECTION AGENCY (EPA), OFFICE OF ENVIRONMENTAL JUSTICE AND EXTERNAL CIVIL RIGHTS (OEJECR).		
7	WHEREAS, the City of Douglas recognizes the importance of addressing environmental and climate justice issues to promote the health, well-being, and sustainability of its communities; and		
8	WHEREAS, the U.S. Environmental Protection Agency's (EPA) Office of Environmental Justice and External Civil Rights (OEJECR) has established the Environmental and Climate Justice Community Change Grants Program to support initiatives that reduce environmental pollution, mitigate climate impacts, and promote sustainable practices in communities facing environmental challenges; and

10	WHEREAS, the Arizona Border Alliance (ABA) has expressed a commitment to partnering with the City of Douglas in applying for the Environmental and Climate Justice Community Change Grant to advance the city's Climate Action Strategy, mitigate pollution, and support environmental justice for all residents; and

12	WHEREAS, entering into a Memorandum of Understanding (MOU) with ABA establishes a framework for		
13 14	collaboration that clearly defines the responsibilities of both parties in pursuing, managing, and implementing the grant program and ensures compliance with all EPA guidelines and federal regulations; and		
15 16	WHEREAS, under the terms of the MOU, the City of Douglas will serve as the lead applicant responsible for grant proposal development, funding of essential water and sewer infrastructure, and managing grant activities, including reporting requirements, while ABA will be responsible for implementing specific grant activities, adhering to the city's Climate Action Strategy, and complying with the EPA's Subaward Policy and all federal regulations;		
17 18	NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Douglas, Arizona, as follows:		
19	1. Authorization to Enter into MOU: The City Council authorizes the city to enter into a Memorandum of Understanding (MOU) with the Arizona Border Alliance (ABA) to collaborate in applying for the Environmental and Climate Justice Community Change Grants Program through the EPA's Office of		
20	Environmental Justice and External Civil Rights (OEJECR).		
21	2. Responsibilities: The City of Douglas will undertake the role of lead applicant, responsible f proposal development, funding essential water and sewer infrastructure to the west for the Port of Ent		
22	(POE), grant administration, and compliance with grant management requirements. ABA will focus on implementing grant activities, aligning with the Climate Action Strategy, and ensuring adherence to federal regulations, including the EPA's Subaward Policy.		
23	3. Effective Date: This Resolution shall be effective immediately upon adoption.
