9 10	WHEREAS, the Arizona Public Service Company needs to install additional electric lines, together with appurtenant facilities and fixtures to facilitate the electrical connections to the temporary well site over the above-mentioned parcel that will also provide power to the new commercial port of entry site; and	
11	WHEREAS , Arizona Public Service Company asks that the city grant a Utility Easement for said purpose more specifically identified in Exhibit "A" attached.	
12 13	NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Douglas, Arizona, as follows:	
14 15	Section 1. Approve and ratify previous action on the subject easement and hereby grant the Utility Easement, a copy of which is attached as Exhibit "A" and incorporated herein by reference, is in the best interest of the City of Douglas.	
16 17	Section 2. The City Manager and the City Clerk are hereby authorized to execute and deliver the Utility Easement and any related documents necessary to the consummation of the transaction contemplated by the Utility Easement for and on behalf of the City of Douglas.	
18	Section 3 . The officers of the City Council and the City of Douglas are hereby authorized and directed to fulfill all obligations under the terms of the Utility Easement.
