7	WHEREAS, the North American Development Bank (NADB) is an international organization created pursuant to the Agreement between the Government of the United States of America and the Government of the United Mexical States concerning the Establishment of a North American Development Bank; and one of the purposes of NADB is authorized to provide assistance for the development of environmental infrastructure projects in the border region and

10	WHEREAS, the Mayor and Council of the City of Douglas recognize the need to develop an Operation and Maintenance Manual for the Wastewater Treatment Plant; and has requested funding for this purpose; and
11	WHEREAS , the grant funding to be provided by the North American Development Bank (NADB) is a notable financial infusion to provide for the completion of documentation for the certification process at the City of Douglas Wastewater Treatment Plant; and
13	WHEREAS , the terms and conditions of said Wastewater System Grant Agreement to be entered into by the parties are attached as Exhibit "A", and incorporated herein by reference; and
14	NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Douglas as follows:
15 16	Section 1. The terms and conditions of the NADB Wastewater System Grant Technical Assistance Agreement, in the funding amount of \$ 30,000 from NADB-PDAP, are found to be in the best interest of the City of Douglas.
17	Section 2. The terms and conditions of said NADB Wastewater System Technical Assistance Grant Agreement to be entered into by the parties are hereby authorized and approved, and are attached hereto as Exhibit "A", and incorporated herein by reference as though fully set forth herein verbatim.
18	Section 3. The City Manager, the City Clerk as well as the Public Works Director are hereby authorized to execute and deliver any documents necessary to consummate the transaction contemplated by this grant agreement for and behalf of the City of Douglas.
