NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Douglas,

Section 1. There is hereby levied on each one hundred dollars (\$100.00) of the assessed value of all property, both real and personal, within the corporate limits of the City of Douglas, except such property

as may be by law exempt from taxation, a primary property tax rate of 1.1519 per \$100 of assessed valuation for the fiscal year ending on the 30th day of June, 2023. If such rate generates a levy that exceeds

the maximum levy allowed by law, the Board of Supervisors of Cochise County is hereby authorized to

Section 2. Failure by the officials of Cochise County to properly return the delinquent list, or any

irregularity in any proceeding shall not invalidate such proceedings or invalidate any title conveyed by any tax deed; failure or neglect of any officer or officers to timely perform any of the duties assigned to

them shall not invalidate any proceeding or any deed of sale pursuant thereto; the validity by which the collection of the same may be enforced shall not affect the lien of the City of Douglas upon such property

for the delinquent taxes unpaid thereon; overcharge as to part of the taxes or of cost shall not invalidate any proceeding for the collection of taxes or the foreclosure of the lien therefore or a sale of property

Severability: If any chapter, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance and

Section 4. All Ordinance and parts of ordinance in conflict herewith are hereby repealed.
