10	the next twelve (12) months, through August 15, 2023; and
11	<b>WHEREAS,</b> Amendment No. 1 providing the terms and conditions of said agreement, identified as Amendment No. 1 to Contract No. 18-002-23, is attached and incorporated herein by reference; and the terms and conditions of the Contract No. 18-002-23, is attached as Exhibit "A" and incorporated herein by reference; and

17	<b>Section 2.</b> The City Manager and the City Clerk are hereby authorized to execute and deliver ADCRR Contract No. 18-002-23, attached as Exhibit "A", and any related documents necessary to consummate the transaction contemplated by the agreement, for and on behalf of the City of Douglas.
18	Section 3. The officers of the City Council and the City of Douglas are hereby authorized and directed
19	to fulfill all obligations under the terms of said Intergovernmental Agreement.
