7. DISCUSSION/DECISION on APPROVALS.



A. FIRST READING OF ORDINANCE NO. 22-1143, an Ordinance of the Mayor and Council of the City of Douglas, Cochise County, Arizona, ADOPTING "2022 AMENDMENTS to ARTICLE 5 of the ZONING REGULATIONS" by reference to AMEND SECTION 510.1, SECTION 510.2, SECTION 501.7, SECTION 501.8, AND SECTION 513.1, RENUMBER and AMEND SECTION 513.2, SECTION 513.3, and SECTION 513.4, and ADD SECTION 513.2, PERMITTED USES, and SECTION 513.3, PROPERTY DEVELOPMENT STANDARDS, of the CITY of DOUGLAS ZONING REGULATIONS; Providing for Severability; and establishing an effective date thereof.

William Osborne provided the following bullet points:

Motion by Council Member Grijalva, second by Council Member Shelton to approve the placement of Ordinance No. 22-1143.

Council Member Lindemann mentioned that years back there were apartments in the downtown area and also in the YMCA building that Cochise College students would utilize and inquired if the proposal was going to be flexible to have apartments again if needed.

Mr. Osborne agreed.

Additionally, Council Member Lindemann inquired if the same requirements would apply to the Heavy Industry area.

Mr. Osborne responded for property development standards there would be flexibility due to properties less than five acres in size and they would need to go through the Planning and Zoning Commission to get approvals. Mr. Osborne continued to say it would not be an administrative process.

Council Member Lindemann inquired if it would change from Heavy Industry.

In response, Mr. Osborne stated it would continue to be Heavy Industry.

Further, Council Member Lindemann asked if the screening requirements was still in place.

Mr. Osborne agreed.

Council Member Grijalva thanked Mr. Osborne for the presentation and for the awareness provided to council on the existence regulations since it wasn't business friendly, however, with the new regulations new businesses or offices would come in to bring employment to the community. Additionally, Council Member Grijalva commented that a greater vision needed to be viewed for the city's best interest and for the need of constituents.

Council Member Baldenegro inquired if any members of the public wanted to address council on the item.

Mr. David Studer from 2630 14th Street addressed the council and stated he attended the last planning and zoning meeting and that changing the rules prior to doing anything would be ideal for people to have the same opportunities. Additionally, Mr. Studer inquired on the fire suppression according to the city code included 8,000 sqft., and if it would change or if apartments would be grandfathered in.



Further, Mr. Studer stated he was in support of the item being that he is a businessman, and this would bring flexibility to businesses.

Ida Pedrego of 1815 5th Street stated it would be a good opportunity for the community and inquired on the already established businesses, and if they would be grandfathered in. Additionally, Ms. Pedrego commented there are other things that need to be looked into and also supported the item as it would be a great opportunity for the community.

Council Member Grijalva inquired if Mr. Studer's concerns could be addressed before the third reading.

Ms. Urquijo responded it would be worked on.

Mr. Osborne added that the uses that are in place are grandfathered in and for other zonings, the city is adding to the uses in place already. Further, Mr. Osborne stated that current properties use would be fine, but if there was opportunity to invest in the buildings, the city would allow flexibilities and uses wouldn't change.

Moreover, Mr. Osborne stated that in reference to fire suppression, the Fire department, Business licenses and Development Services would make sure they are up to date with applicants during the process and concerns are raised upfront.

B. **RESOLUTION NO. 22-1488**, a Resolution of the Mayor and Council of the City of Douglas, Cochise County, Arizona, DECLARING as a PUBLIC RECORD that certain document filed with the CITY CLERK and ENTITLED "2022 AMENDMENTS to ARTICLE 5 of the ZONING REGULATIONS" regarding amending the CITY of DOUGLAS ZONING REGULATIONS relating to the HEAVY INDUSTRY and HISTORICAL PRESERVATION OVERLAY ZONE and AMENDING SECTION 510.1, SECTION 510.2, SECTION 501.7, SECTION 501.8, and SECTION 513.1, RENUMBERING and AMENDING SECTION 513.2, SECTION 513.3, and SECTION 513.4, and ADDING SECTION 513.2, PERMITTED USES, and SECTION 513.3, PROPERTY DEVELOPMENT STANDARDS, of the CITY of DOUGLAS ZONING REGULATIONS.

Denis Fitzgibbons provided background information and stated the city was trying to lower publication costs; therefore, the city charter section 14 allowed the city to adopt city code provisions by reference. Mr. Fitzgibbons stated that publications are charged based on how lengthy codes are, and this would be based on city charter section 7 and state statute 9-802 in which would allow cities to adopt longer code sections by declaring of public record and the ordinance is the only document to published.

Lastly, Mr. Fitzgibbons commented that it would provide notice on where to find such documents and it's a method to make the city more efficient and publication costs as a city.

Council Member Grijalva thanked Mr. Abe Villareal from Cochise College who invited Council Member Shelton and him to be part of a civility conversations panel.

Additionally, Council Member Grijalva thanked Diane's Photography for hosting the Douglas Business Network mixer for February, Ms. Urquijo for the future vision presentation, and Mayor Pro Tempore for attending.

Moreover, Council Member Grijalva invited the public to support the Douglas Bulldogs Baseball Team vs. Cholla at 5pm, and the game would be dedicated to veterans.

Further, Council Member Grijalva stated he had been working with Paul Franco of Infinite Power Energy Solutions, Scottie Babicky from the American Legion, Fabian Ochoa-Coach for Douglas, and Angel Ortega-Athletic Director for organizing the event as it wouldn't be possible without the generous donations of Mr. Franco and the American Legion for the summer games uniform.

As an additional comment, Council Member Grijalva commented there would be three alumni Bulldogs throwing the first pitch and veterans will be in attendance as well.

Mayor Pro Tempore Morales congratulated Council Members Lindemann, Shelton and Grijalva on their reelection and stated is looking forward to continuing to work with them since council has a lot of great things to do ahead.
