Procurement Justification: Other Governmental

Award Type (How Awarded): Administrative

This contract change will cause an increase to the contract value for the fiscal year that will exceed the previously posted estimated annual expenditure in total by 25% or \$100,000 whichever is less, and a repost with the updated amount is required per rule R2-201.1 of the Procurement Code.
