Thence Northeasterly along the arc of said curve through a central angle of 21°40'13" (21°38'07" record) a distance of 137.08 feet (136.89 feet record) to its point of tangency; Thence North 85°00'02" East 63.19 feet (North 84°49'08" East 63.19 feet record) to the point of curvature concave Southeasterly, having a radius of 422.70 feet (422.51 feet record);

Thence Northeasterly along the arc of said curve through a central angle of 21°36'55" (21°38'07" record) a distance of 159.47 feet (159.54 feet record) to the curve's end and to the east line of said Exhibit 4 parcel;

Thence departing said north right-of-way line, along said east line, South 16°36'57" West 60.00 feet (South 16°34' West record) to the Southeast corner of said Exhibit 4 parcel, said corner also being on the south right-of-way line of a 60.00 foot wide street and to the beginning of a non-tangent curve, concave Southeasterly, the center of which bears South 16°36'57" West, having a radius of 362.70 feet (362.51 feet record);

Thence along said south right-of-way line and the south line of said Exhibit 4 parcel, Southwesterly along the arc of said curve through a central angle of 21°36'55" (21°38'07" record) a distance of 136.83 feet (136.89 feet record) to its point of tangency;

Thence South 85°00'02" West 63.19 feet (South 84°49'08" West 63.19 feet record) to the point of curvature concave Southeasterly, having a radius of 422.44 feet (422.51 feet record);

Thence Northwesterly along the arc of said curve through a central angle of 21°40'13" (21°38'07" record) a distance of 159.77 feet (159.54 feet record) to its point of tangency;

Thence North 73°19'45" West 813.31 feet (North 73°32' West record) to the Southwest corner of said Exhibit 4 parcel;

Thence departing said south right-of-way line and said south line, along the west line of said Exhibit 4 parcel, North 16°40'15" East 60.00 feet (North 16°27'15" East record) to the POINT OF BEGINNING.
