As an employer of 20 full-time employees, the City of the Village of Douglas currently provides employees with health and dental benefits through Lighthouse Group. They provided 10 proposed health options for consideration. The Options were from Priority health, and Blue Care Network.

As the City considers healthcare coverage for its employees it must also balance the financial benefits and constraints to the City, the benefit needs of the employees, and regulatory requirements such as Public Act 152.

Based on discussions during the budget workshops, the recommended action being presented tonight is to renew the current priority health insurance plans, continue the HSA City contribution policy of \$500 less than the deductible of the high deductible plan, and to set the employee co-share contribution rate of \$50/month. Renewing the City's current Delta Dental plan will not result in any change in premiums.

Health insurance costs are subject to numerous external factors, including medical inflation, regulatory changes, and market dynamics. Despite our best efforts to manage costs efficiently, fluctuations are inevitable. These increases align with prevailing trends and ensure that our employees continue to receive comprehensive coverage without undue financial strain on the City.

However, I recognize the importance of exploring avenues to mitigate future increases and enhance cost-effectiveness. To this end, we propose collaborative efforts between city employees and Lighthouse to evaluate strategies for FY25/26 rates. By engaging employees in this process, we harness their insights and collective expertise to identify viable solutions that balance cost containment with maintaining high-quality benefits.

I am committed to presenting a range of options in the next budget cycle that prioritizes both fiscal responsibility and the well-being of the workforce. By proactively addressing healthcare expenditure concerns, we aim to safeguard the financial sustainability of the organization while upholding the city's commitment to supporting employee health and welfare.

I recommend that City Council approve resolution 10-2024 approving Fiscal Year 2024-2025 insurance plans, HSA contribution rates, and employee contribution rates.

WHEREAS, Council has chosen to set employee contribution levels at \$50 per month.
