**RESOLUTION**

**WHEREAS**, the Westshore Association has requested that the City of the Village of Douglas accept Golfview Drive, a private road within the Westshore development, as a public roadway; and

**WHEREAS**, pursuant to Division 2 – Acceptance of Private Roads of the City Code of Ordinances, the Planning Commission is required to review such requests and provide a recommendation to the City Council; and

**WHEREAS**, the City Engineer, in a report dated September 3, 2025, reviewed the existing conditions of Golfview Drive and provided findings and recommendations regarding roadway construction, compliance with City standards, and long-term maintenance considerations. The City Engineer concluded that the roadway meets City requirements as it currently exists and may be accepted as a public road if Council so decides; and

**WHEREAS**, the Planning Commission, at its regular meeting on November 13, 2025, voted - to recommend that the City Council approve the request to accept Golfview Drive as a public road.

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS THAT THE CITY COUNCIL OF THE CITY OF THE VILLAGE OF DOUGLAS HEREBY ACCEPTS GOLFVIEW DRIVE AS A PUBLIC ROADWAY, CONTINGENT UPON:**

1. Recorded dedication and legal description approved by the City Attorney.
2. All necessary easements and ROW documents shall be recorded.
3. Stormwater system and related drains shall be transferred to the Allegan County Drain Commission (ACDC), with all required easements and documents provided to the City for review and approval.
