Contract engineers have identified last design elements that need updating, including SCADA, Headworks, TLAP plant tie in, and reuse Chlorine system. The items needed to be revisited do to product/ material updates, and strategic planning changes. We are on schedule to finalize design by end of the year and start construction at the beginning of 2026.</p>	

Dripping Springs Retail Water Update:

Stage 2 watering restrictions are in place for all CODS water customers. WCP/DCP have been accepted by council on 8/5.

South Regional Water Reclamation Facility Operations Report.

The South Regional Water Reclamation Facility had no violations for the month of August.

Arrowhead Wastewater Plant Update:

Drip field expansion is being finalized. Work will soon start on the GST.

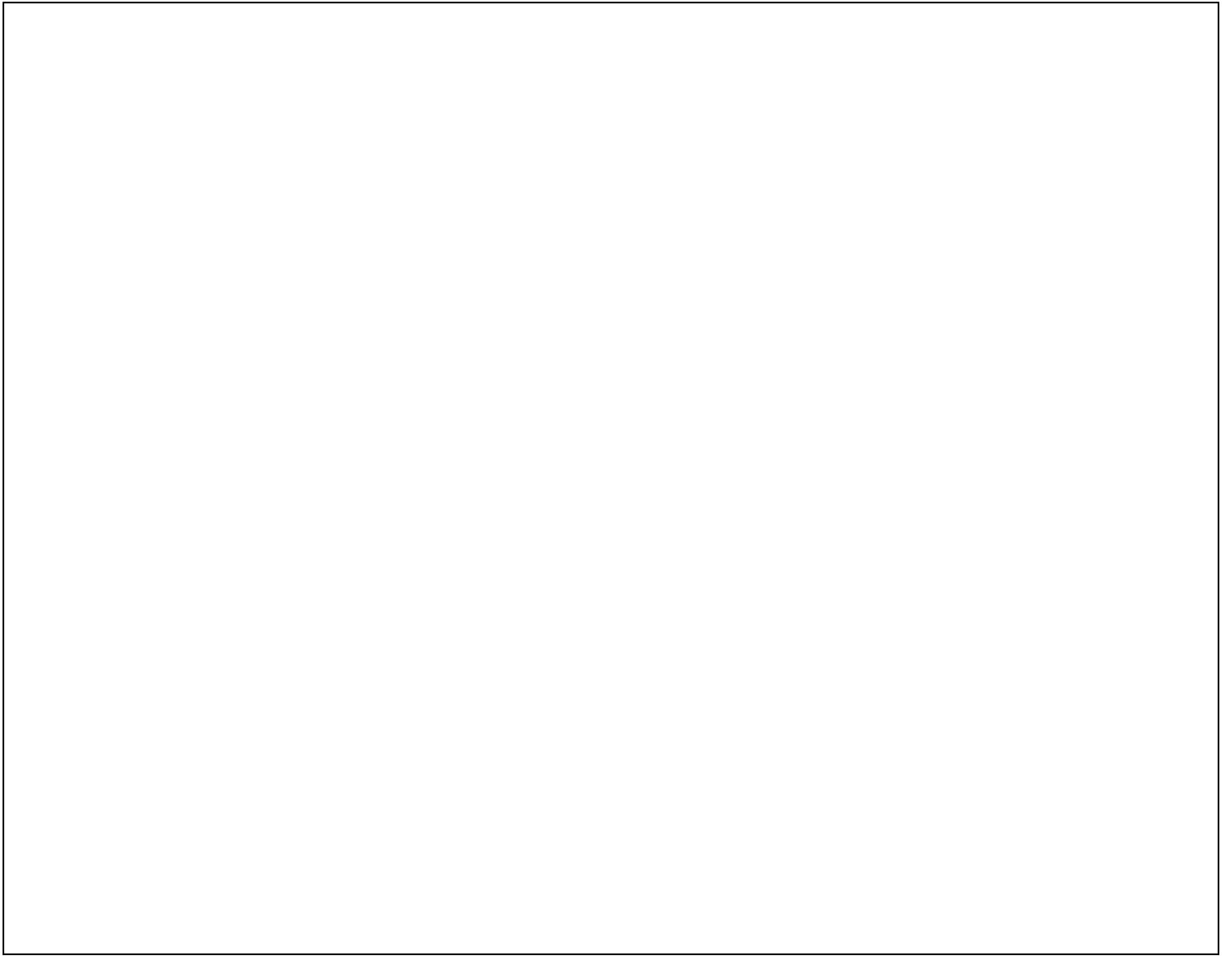
Arrowhead treatment facility operated without any violations for the month of August.
