The Texas Supreme Court has ruled in support of the City of Dripping Springs' wastewater discharge permit. We are

finalizing plans and are looking to go out to bid in the summer and to have construction started by the fall.

#### **Dripping Springs Retail Water Update:**

Stage 2 watering restrictions are in place for all CODS water customers. In final stages of completing WCP/DCP and DCP for Driftwood golf course

### South Regional Water Reclamation Facility Operations Report.

The South Regional Water Reclamation Facility operated without any violations for the month of June.

#### **Arrowhead Wastewater Plant Update:**

Bid Package has been received for GST and drip field work. City has awarded contract to CCCarlton. Construction has started and will approximately take 3 months


Arrowhead treatment facility operated without any violations for the month of June.

Big Sky Treatment Plant operated without any violations for the month of June.

#### **Update on Reclaimed Water:**

Founders Park reclaimed water usage was 551,926 gallons for the month of June with a daily average of 18,397 gallons per day. Sports Park reclaimed water usage was 1,074,655 gallons for the month of June with a daily average of 35,822 gallons per day. Total usage was 1,626,581 gallons with a daily average of 54,219 gallons used per day. We are averaging 20% of effluent disposal going towards 210 application.
