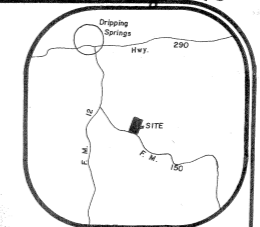


CURVE "A"

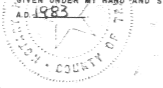
