Last Month's Market News:

Sales

With five markets in October, the month set the highest total sales since I've been counting.

Vendor Issues:

Apache Spirit Bison left the market on 10/31. He was selling processed pecans 10/17. I asked him to remove them from his booth and update his application if he wanted to continue. He waved me off. I followed it up with an email and at the next market he let me know he would not be returning, as he preferred less regulated markets.

November 6th Market: There was another event starting at DSRP as market closed. This caused a large traffic block that required us to sort out. Combined with the first day of early sunset, it was difficult to see and very crowded. (we had put our lights out in pedestrian areas but it was still dark.) Anna Moore was at her second market with her booth, Oma's Furry Friends. Her husband drives her, and he lost patience in line to enter, gesturing and yelling. When the entrance cleared enough for him to enter, he sped into the building, ignoring a shouting Johnna, who was directing traffic at the entrance, and came three inches from hitting a woman who was walking out from the other event. (We talked her out of submitting a complaint afterward.) I had to pull Johnna away from Anna's husband and told Anna it was their last market, as that was a blatant disregard for safety and instructions. Subsequent emails with Anna found an agreement that he would no longer be allowed in the building, but she could set up outside. She will likely not return, as there are existing family issues.
