10' Option: Produce a 10' x 10' canopy tent with full-color print. Sturdy aluminum frame with black nylon carry bag and ground stakes.

Total \$1,580

4 sand bags – durable nylon holders with straps and 2 sleeves in each filled with sand \$120

Optional Backdrop: 115" w x 82.5" h full color single sided dye-sublimation print with Velcro straps along top/down sides and pole pocket at bottom for steel pole. Steel pole included. \$960

Optional sidewalls: 115" w x 41" h full color single sided dye-sublimation print with Velcro straps along top/down sides and pole pocket at bottom for steel pole. Steel pole included. \$480 each

15' Option: Produce a 15' x 10' canopy tent with full-color print. Sturdy aluminum frame with black nylon carry bag and ground stakes.

Total \$2,240

6 sand bags – durable nylon holders with straps and 2 sleeves in each filled with sand \$180

Optional Backdrop: 172.5" w x 82.5" h full color single sided dye-sublimation print with Velcro straps along top/down sides and pole pocket at bottom for steel pole. Steel pole included. \$1,180
