**10/15 MOCIC Meeting**

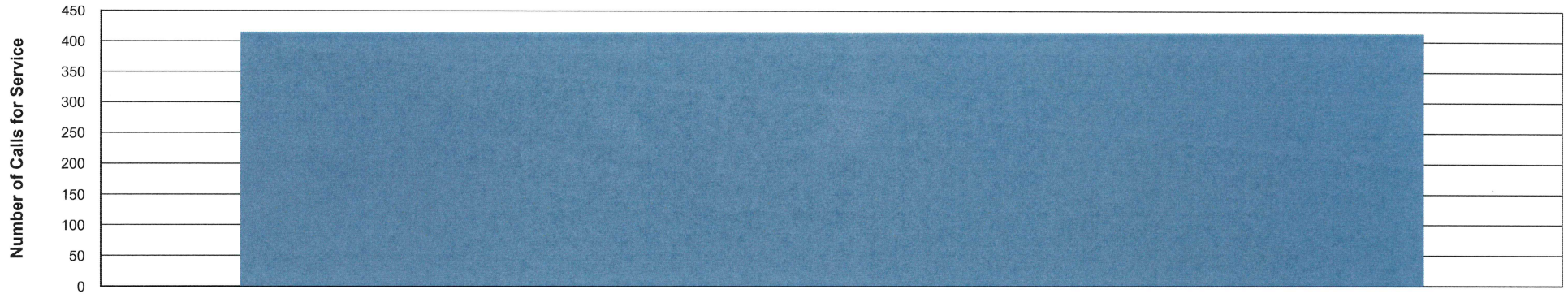

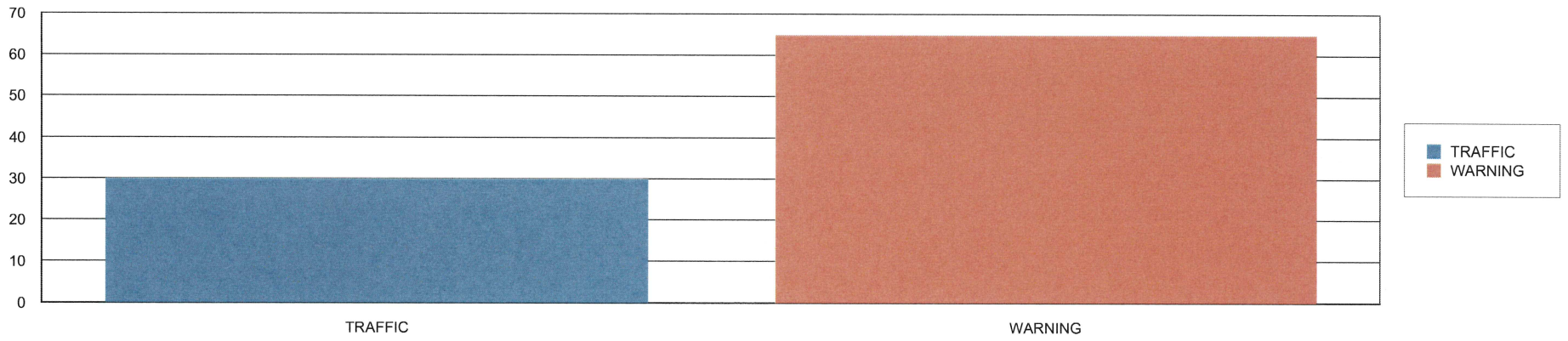
