



FIGURE 3.3: Development Concept/Future Land Use Map



# New public school is best for both systems

The Hatfields and McCoys, the Montagues and Capulets. The Empire and the Rebellion.

Perhaps the battle over putting a public grade school in Dyersville isn't quite as divisive as those legendary feuds. Still, the fact that the controversy over whether or not to build an elementary school in the city is controversial is not surprising.

argument over building a public school in a city of 4,000 looking from outside the area.

Many arguments have been offered for and against a pre-K through fourth grade public elementary school being built within the city limits of Dyersville. Thoughtful input was also brought forward both for and against - by citizens residing within the Western Dubuque County Community School District at a public meeting on the subject June 22.

broken down and analyzed, it is difficult to make an argument in favor of the city maintaining what is essentially a parochial-only system -

the outdated public pre-K - K building on Third Avenue SE notwithstanding.

While the goal of public and private schools is education, the two systems have different approaches to achieve that goal, two approaches that will appeal to different sets of people.

The argument from those On closer inspection, the favoring a public school option was never that the city's longstanding tradition would be surprising to anyone of parochial schools should be eliminated. As many voicing their opinions on June 22 stressed, both school systems have co-existed for decades in towns surrounding Dyersville.

One citizen commented at the meeting that if parents are sending their children to the parochial school for the "right reasons," it should continue to do just fine. If children are being sent there out of necessity because it is the lone option in town, that probably isn't a good After all of the input is enough reason for the student, or the parochial school.

> Also on the list of insufficient reasons to not build a public grade school is taxes. The funding of the public

school's construction costs is through the state penny tax and the building's operating costs are paid for out of the district's general fund, which is calculated solely on a state formula based on student head count in the district and not on the amount of school buildings in the district.

While no one likes paying higher property taxes, those higher taxes would only come in the wake of a significant student attrition rate from the private school, which is unlikely, if parents are sending their children to parochial school because they truly believe it is best for their children and are willing to continue to support

What's more, property taxes in the WD district, according to district officials, are already relatively low at a rate of \$13.11 per year as opposed to Dubuque's district (\$16.88), the MV district (\$15.88) and the Ed-Co district (\$14.41).

Putting property taxes ahead of what is best for education, which includes Dyersville having healthy parochial and public grade school options, is not in the interest of the greater good. nor is it in the interest of the future of Dversville, according to letters submitted to the WD board from the boards of the Dyersville Economic Development Corporation and the Dversville Area Chamber of Commerce stating support for building a public elementary school.

Public school districts have an obligation to provide "neighborhoodschools" to their constituents. There is nothing "neighborhood" about firstgraders living within Dversville's city limits needing to hop on a bus to be transported to Farley to attend grade school. For the 2008-09 school year, 311 grade school-aged kids from the Dyersville area already are enrolled with the WD district - more than enough to justify a pre-K through fourth-grade building in the city, where many students will be able to walk to and from school.

In a similar comparison, despite booming Peosta, enrollment at its public grade school, will see a new Seton parochial school being built soon, revealing there is no lack of interest in parochial schooling.

"Builditand they will come," is a popular catch phrase that will be forever linked to Dversville. The city's parochial grade school has been recently added on to and upgraded, and a public grade school will likely be built with an eye toward opening for the 2011-12 school year. A public school will likely lure new families to Dyersville and its outlying areas, likely luring new businesses, which will serve the greater good and make for a stronger Dversville.

The time is long overdue for Dyersville to offer its citizens both parochial and public grade school options within its city limits. Pursuit of monopolies should be confined to the board game. They have no place in education.

Employee of school and I worries for the safety of my students.

For the safety of our children this hotel can be put elsewhere. I am excited for the new Development but perhaps a better location for something like this is better off across the tracks on the belt line.

Safety and well being on my children at Dyersville Elementary. The location will have presence of unfamiliar individuals near where my children play outside at recess. Strangers will have access and be able to overlook the school and outside areas. Hotels bring in criminal activity (there are studies shown) and my children do not need to be around that.

Safety of the children

I may not have kids that attend but I am a PreK teacher at Dyersville Elementary and this is not an acceptable location for a hotel.

There is no reason for a hotel to be so close to a school where there are children running and playing. There are way too many safety concerns that could not be covered to protect these children from the unknown additional crowd of people!

It's easy to not care about this when it doesn't affect your kids, but the city council would never have allowed this to be built near the schools where they sent their children. The kids at this school are as valuable and worthy as their kids and grandkids. Everyone who has kids in this town should care about the issue.

I work at DES and my children will attend there in upcoming years.

As a parent that is potentially sending her children to school there someday, this is HORRIBLE. Use you brains city of Dyersville!!

Safety for children and traffic concerns need to be taken into consideration. I do not have children attending the school, however I will have grandchildren in the upcoming years.
I don't even live in the neighborhood or have my own children attending Dyersville Elementary School, but realize what a huge safety concern this would be. As a teacher myself, I would be very apprehensive about a hotel development being so close to my students' playground and the amount and variety of people that would have close access to the school. My own children attend another school in the district and as a parent I would be very upset if this was proposed next to their school.
Safety of our children is first and foremost, putting a hotel (not even needed) next to a school is not putting our children as priority.
Please do not build hotels by the school. The kids should be able to feel safe in a safe community and that's putting their safety at risk!
