## **ORDINANCE #2008-6**

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, FLORIDA AMENDING ORDINANCE #2006-7, SECTION TWO, DECREASING THE THRESHOLD DOLLAR AMOUNT, PROVIDING FOR CONFLICTS, SEVERABILITY, ANDAN EFFECTIVE DATE.

**WHEREAS**, the Town wishes to amend Ordinance #2006-7, Purchasing Policy Procedures for the Town of Eatonville.

NOW THEREFORE BE IT ENACTED BY THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, FLORIDA THE FOLLOWING:

SECTION ONE:	Dollar Threshold, Approval Required:					
Less than \$500.00-	This amount requires the approval of the Department Head					
\$501.00 to \$2,000-	Must have three (3) written quotes and have report attached to Requisition. (Must have approval of purchasing manager and Mayor).					
\$2,000 and over-	(Must have Town Council approval).					
\$5,000 and over-	must have formal sealed, competitive procedures.					
SECTION TWO:	<u>CONFLICTS:</u> All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.					
<b>SECTION THREE:</b> <u>SEVERABILITY:</u> The provisions of this Ordinance are declared to be separable and if any section, sentence, clause or phrase of this Ordinance shall be for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses and phrases of this Ordinance but they shall remain in effect. It being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.
