

RESOLUTION NO. 2025-3

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, FLORIDA, APPROVING THE ADMINISTRATION TO PROCEED FORWARD WITH THE SUBMITTAL OF PROPOSED CATALINA STORMWATER PARK AND MITIGATION PROJECT. THIS PROJECT WILL RECEIVE FUNDING FROM THE ORANGE COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT – DISASTER RECOVERY(CDBG-DR) AND RESOURCES TO THE TOWN OF EATONVILLE, PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS the Town of Eatonville desires to request 15 million dollars in funds from the CDBG-DR Infrastructure, Public Facilities and Mitigation to serve the community stormwater planning, acquisition of land, resilience hub, and drainage infrastructure throughout this high-risk flooding zone; and

WHEREAS the Orange County received a total of \$219,712,000 in Community Development Block Grant - Disaster Recovery funds (CDBG-DR), to include \$191,054,000 for unmet needs and \$28,658,000 for mitigation, to address community impacts and damages associated with Hurricane Ian.

WHEREAS the town of will provide planning, design, and construction for this stormwater park, along with community meeting to ensure the residents input on the final layout; and

WHEREAS the funding for planning activities, to include data gathering, studies, analysis, plan preparation, and the identification of actions that will implement such plans. Examples of projects include, but are not limited to infrastructure studies (stormwater, floodplain studies); resilience and sustainability studies; mitigations studies, etc.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Eatonville, Florida as follows:

SECTION 1. That the Council of the Town of Eatonville hereby approves the administration to proceed forward with submittal and request for 15 million dollars for the proposed Catalina/ Frances Jerry stormwater park and mitigation project to the Town of Eatonville.

SECTION 2: CONFLICTS: All Resolutions or parts of Resolutions in conflict with any other Resolution or any of the provisions of the Resolution is hereby repealed.

SECTION 3: SEVERABILITY: If any section or portion of a section of this Resolution is found to be invalid, unlawful or unconstitutional, it shall be held to invalidate or impair the validity, force or effect of any other section or part of this Resolution.

SECTION 4: EFFECTIVE DATE: This Resolution will take effect immediately upon its passage and adoption.
