

RESOLUTION CRA-R-2026-11

A RESOLUTION OF THE TOWN OF EATONVILLE COMMUNITY REDEVELOPMENT AGENCY (TOECRA) BOARD OF DIRECTORS, ADOPTING THE AUTHORIZED SIGNATURE TWO (2) REQUIREMENTS FOR CHECKS SIGNATURES ON THE TOECRA BANK ACCOUNT WITH TD BANK AND PROVIDING FOR ONLY THE ELECTED MEMBERS AS AUTHORIZED SIGNORS FOR ALL TOECRA CHECKS PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS the members of the governing body and two (2) additional members from the taxing authorities serve as Board of Directors of the Agency; and

WHEREAS, such members constitute the head of a legal entity, separate, distinct, and independent from the governing board of the County and Municipality; and

WHEREAS, the Board of Directors establishes an operational two signature requirement for all checks from TD Bank; and

WHEREAS, the Board of Directors of the TOECRA designates that any five (5) members of the Town Council are authorized to sign checks for the Town of Eatonville Community Redevelopment Agency.

WHEREAS the Town of Eatonville Community Redevelopment Agency TOECRA currently have a banking Treasury Trust Account with TD Bank; and

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE TOWN OF EATONVILLE COMMUNITY REDEVELOPMENT AGENCY , THE FOLLOWING:

SECTION ONE: The Board of Directors of the TOECRA designates all elected members serving on the Board of Directors as signors shall on the TOECRA bank account with TD Bank.

SECTION TWO: The Board of Directors of the TOECRA designates that any two (2) members of the Town Council are authorized to sign checks for the TOECRA.

SECTION THREE: The designated Town Council members as check signers are as follows:

SECTION SIX: EFFECTIVE DATE: This Resolution shall become effective immediately upon its passage and adoption.
