1. CALL TO ORDER AND ROLL CALL

Consideration and Possible Action On:

A. Presentation by Eden Consolidated Independent School District President

Tony Lozano, the Eden Consolidated Independent School District Board President, made a presentation to Council about the Eden CISD School Board scholarship. To raise money for the scholarship, the School Board is wanting to host a night golf tournament. The golf tournament will be held on November 9, 2024 starting at 3pm. The first 9 holes will be played in the afternoon and the second 9 after it gets dark. Mr. Lozano asked Council if they would be willing to waive the green fees for the night golf tournament.

C. Transfer of \$150,000 funds from the City's IGA Account #278547 to the City's Pool Cash Account #6041

Priscilla Aguirre explained to Council that the payments for the new vehicle and repairs on the water plant are coming up. The total for these 2 would be around \$72,000. She also presented a quote for the new truck that included a trade in value of \$1,000 for an older truck that has been parked.
