To honor John Molloy Harrod a long standing citizen of Eden, Concho County, Texas from his date of birth July 4th, 1916 until his death and is buried in the Eden Cemetery.

He served in WWII.

He served as the Concho County Attorney for many years and his office was located where the dental office is now.

He and his wife raised three daughters named Katherine, Lillian and Margaet all of whom graduated from Eden High School.

John, his Mother and Grandparents were instrumental in obtaining the land and building for the current St Charles Catholic Church on which Petty street begins.

Petty Streets ends where John Molloy Harrod's house is located and his daughter now resides there. She would be honored for the street to be named after her Father.

There are enough Petty street signs to relocate where the current Harrod street is now. There are only three blocks. The City of Eden workers could switch the signs.



A mp of the streets are attached.


A sample of the desired street to replace current Harrod sign.


