<b>Friday, August 25, 2023</b>	OCPA mails out the Notice of Proposed Property Taxes OCPA mails out the Notice of Proposed Property Taxes no later than <b>55 days</b> after certification of value. (TRIM Notice) Form DR-474, this is the advertisement of the 1 <sup>st</sup> TRIM hearing
<b>Tuesday, September 5, 2023 at 6:30 pm</b> Special Council Meeting (must be held between Sept 4-19)	<b>Public hearing/adoption of the tentative budget &amp; proposed millage;</b> (cannot be held on BCC hearing dates of <b>9/7 or 9/21</b> or OCPS hearing dates of <b>8/1 &amp; 9/12</b> )
<b>Thursday, September 14, 2023</b>	Advertise in the newspaper the public hearing/adoption of the final millage & budget (must be done within 15 days after the public hearing/adoption of the tentative budget & proposed millage)
<b>Tues., September 19, 2023 at 6:30 pm</b> Regular Council Meeting (must be held within 2-5 days after advertisement)	<b>Final public hearing/adoption of millage &amp; budget;</b> (cannot be held on BCC hearing dates <b>9/7 or 9/21</b> or OCPS hearing dates of <b>8/1 &amp; 9/12</b> )
<b>Friday, September 22, 2023</b>	Send ordinance adopting final millage & budget to OCPA, tax collector, and DOR ( <b>must be done within 3 days of final hearing</b> ). When the property appraiser receives the resolution or ordinance, notification of the final millage rate is considered official.
<b>Friday, September 29, 2023</b>	OCPA delivers DR 422 and DR-420MM with the final tax roll and supporting documents.
<b>Tuesday, October 3, 2023 at Noon</b>	City deadline to return DR 422's to OCPA with final millage rate (NOON)
<b>Wednesday, October 18, 2023</b>	Submit TRIM compliance package (due within 30 days of the final hearing)
