APPROVAL OF A CONDITIONAL USE PURSUANT TO THE EFFINGHAM COUNTY ZONING ORDINANCE

BE IT ORDERED by the **Board of Commissioners of Effingham County, Georgia** (hereinafter referred to as the “**Board of Commissioners**”), in regular meeting assembled and pursuant to the authority granted by the laws of the State of Georgia and the Effingham County Zoning Ordinance, that the following decision is hereby rendered:

Application

An application was submitted by Michele Shuman requesting approval of a Conditional Use to operate a home-based financial planning business within the AR-1 zoning district on a ±0.79-acre parcel identified as Tax Parcel 296-46, located at 1447 GA Hwy 17 South in Commission District 1.

Public Hearings and Notice

Notice of the required public hearings was published in the **Effingham County Herald**, the official legal organ of Effingham County, in accordance with the **Georgia Zoning Procedures Law (O.C.G.A. §36-66-1 et seq.)**.

A public hearing was conducted **on June 16, 2026**, before the Board of Commissioners, with notice published in the Effingham County Herald on **May 27, 2026**.

Findings of Fact

The Board of Commissioners makes the following findings regarding this conditional use request:

1. The applicant requested approval of a Conditional Use to operate a home-based financial planning business on a ±0.79-acre parcel identified as Tax Parcel 296-46, located in Commission District 1.
2. The subject property is zoned AR-1(Agricultural–Residential), and pursuant to Section 4.1A of the Effingham County Code of Ordinances, residential businesses involving customer interaction require Conditional Use approval within this zoning district.
3. Notice of the required public hearing was provided in accordance with the Georgia Zoning Procedures Law.
4. A public hearing was conducted before the Board of Commissioners.
5. The Board of Commissioners reviewed the application, staff report, and all information presented during the public hearing.
6. The Board of Commissioners finds that the proposed Conditional Use is compatible with surrounding land uses, will generate minimal traffic, and is consistent with the intent of the AR-1 zoning district and the Comprehensive Plan.

Conditional Use Approval

The Board of Commissioners hereby approves the Conditional Use to operate a home-based financial planning business on the subject property (Tax Parcel 296-46), located in Commission District 1.
