

AMENDMENT No. 8
AGREEMENT
For
OPERATIONS, MAINTENANCE AND MANAGEMENT SERVICES

This Amendment No. 7 (hereinafter referred to as “Amendment”) is made by and between **The Board of Commissioners of Effingham County** (hereinafter referred to as “County”) and **EOM Operations, a division of EOM Public Works, LLC** (hereinafter referred to as “EOM”).

WHEREAS, the County and EOM entered into an Agreement for Public Works Operations Management Services dated June 20th, 2017 for Public Works Operations Management Services defined to include the County’s department of Public Works, Fleet Maintenance, Water Distribution and Wastewater Collections and Treatment (hereinafter referred to as the “Agreement”); Amendment 1 dated August 7th, 2018; Amendment 2 dated August 20th, 2019; Amendment 3 dated September 15th, 2020; Amendment 4 dated October 19th, 2021; Amendment 5 dated June 21st, 2022; Amendment 6 dated July 18th, 2023; Amendment 7 dated August 20th, 2024 and

WHEREAS, the parties desire to amend the provisions of the Agreement; and

NOW, THEREFORE, in consideration of the foregoing and the mutual promises in the Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below.

1. This Amendment allows for a change in department operating limits and structure to reflect the 2025-2026 approved budget. EOM will provide an accounting of the amount spent for each budget in the monthly report.
2. This Amendment increases the Base Fee from Two Million Seven Hundred Ninety-Seven Thousand Twenty-Five Dollars (\$2,797,025.00) to Two Million Eight Hundred Eighty-Nine Thousand Forty-Eight Dollars (\$2,889,048.00).
3. This Amendment amends section 2.3.5 of the Agreement for Public Works Operations Management Services to reflect the additional lift stations added to the system as listed below.
