**Subject:** Ratification of the Railway Crossing Elimination (RCE) Grant Application

**Item Description:** To seek approval from the Effingham County Board of Commissioners to ratify the submission of the Railway Crossing Elimination (RCE) Grant application, requesting \$2.5 million in federal funding for the design phase of the grade-separated railway overpass and new east-west road from McCall Road to SR 21, as part of the Southeast Railway Network (SERN) Project.

## **Summary Recommendation:**

Staff requests the Board's approval to ratify the submission of the Railway Crossing Elimination (RCE) grant for SERN Project 1C, which requests \$2.5 million in federal funding.

## **Executive Summary:**

This staff report seeks approval from the Effingham County Board of Commissioners to ratify the application to the Department of Transportation's Railway Crossing Elimination (RCE) Program. The application requests \$2.5 million in federal funds for the engineering and design phase of Project 1C, which includes constructing a new east-west road and an overpass over the Norfolk Southern Railroad. The project is a critical element of the Southeast Railway Network (SERN) Plan, aimed at improving traffic flow, enhancing safety, and supporting regional economic growth.

# **Background:**

Project 1C of the Southeast Railway Network (SERN) Plan will address the need for a new, grade-separated crossing over the Norfolk Southern Railway, enhancing traffic safety and providing a new, efficient connection between McCall Road and SR 21.

The project includes the construction of a two-mile east-west road that will run parallel to existing power line easements, providing a vital connection to the county's major industrial and residential areas. A new traffic signal will be installed at the intersection of SR 21 and the new road, improving access and reducing congestion.

The project's total cost is estimated at \$27.5 million, with \$2.5 million requested from the RCE Program for the design phase. Effingham County is committed to providing a 20% local match of \$500,000.

## **Financial Impact:**

The total cost of Project 1C is estimated at \$27.5 million. The breakdown of the project funding is as follows:

- Total Design Phase Cost: \$3.0 million
- Overall Project Cost: \$27.5 million (including right-of-way acquisition and construction)
